CONVENTIONS AND NOTES:

- The data set is a series of spreadsheets developed in preparing *Ohio Health Market Review 2022*.
- Files are organized using Microsoft Excel and copied to a zip file for download.
- Most data are taken from the annual statements that each HMO or Ohio accident and health insurer submits to the Ohio Department of Insurance, which follow the standard HMO blank of the National Association of Insurance Commissioners. The detailed financial and enrollment data are generally included for 1994-2021. The spreadsheets also include some second quarter data for certain years. The hospital data are from Medicare facility cost report data downloaded from CMS.
- Most of the files include additional analysis, which begins below the base data tables or in other sheets within the workbook.
